4º COMPETITION RULES AND REGULATIONS - GBF

- **Know and respect the Competition Rules and Regulations**

5º PROMOTER - GLOBAL BOXING FEDERATION (GBF)

- **Professional Promoter License GBF in force**
- **Request permission of GBF for the event**
- **Official document of municipal or any private institution transferring the facilities to hold the event (stamped and signed).**

- **Liability Insurance (R / C) of the event**
- **Payment of fees must be paid one month before the event (approval and title belt, referees and judges etc..)**
- **Proof of payment of fees for approval**
- **The Ring will be in perfect condition and the Sport approved.**
- **Posters of the event with the GBF logos and advertising banners GBF.**
- **Failure to respect the rules and mainly the security ring competitor and not approved and protections used or the supervisor deems unsuitable could be a pretext for canceling the event.**
- **Introduction of documents of federal authorizations**
- **The organizer for the official titles has the obligation to facilitate the fighting video titles and photos of deliveries belt etc.**

6° COACH – ASSISTANTS AND FIGHTERS

- **Maximum corner a coach and two assistants**
- **Sports Passport GBF in order**
- **Federal License Professional GBF (Coach) in force.**
- **Introduce documentation with your DNI to the delegate of GBF**
- **Gym Sports wear (Coach and helpers)**
- **In the environment of the ring no outsider officials, competitors and coaches cited for combat that takes place in the time allowed.**

7° COMPLAINTS - SANCTIONS

- **Complaints are made directly to the delegate of the event and in writing form or during the 10 days following the date of the event shall be paid on the spot bail of € 100 for regional and 500 € for national and international securities claims.**
- **If the complaint is not feasible because it is not proper according to our rules and regulations will not be refunded the deposit being is linked to administrative expenses.**
- **All misconduct, aggressive or annoying directed to the public official will be immediately sanctioned by the delegate for a fine of 50 € and the case will be submitted to the disciplinary commission for final approval depending on the severity of the event.**

SUMMARY – NATIONAL STANDARDS COMMITTEE

The rules that are in this document constitute the official rules (GBF) National Committee which should govern all organizations in the country.

In cases of competition abroad, the regulations of the host country applies

RING:

The Ring must be approved by its dimensions, equipment and surface combat by the Supervisor appointed by the (GBF) National Committee for the event.

Lighting: be willing to at least 3.5 meters from the surface of combat

Dimensions: approved Ring

COMBATES: REGIONAL - NATIONAL

CLASS PRE FIGHT (PF) 16 years to 18 years inclusive

The duration of the contest will be 3 rounds of 2 minutes for the male and female category.

Mandatory helmet - you can not look for the KO the opponent.

Base score: More technical will be declared the winner

The judge assesses only technique, precision and touch beats of the competitors

In case of technical failure or too powerful hit of the opponent in search of KO, the Referee will stop the assault the one more technical will be declared winner.

CLASS D (AMATEUR) from 18 years

The duration of the contest will be 3 rounds of 2 minutes for male and female categories.

Helmet is obligated- you can look for the KO the opponent –

Base score: Three criteria chronologically

EFFECTIVENESS - TECHNICAL – OFFENSIVE

The most effective will be declared the winner.

To pass from CLASS D to CLASS C need to get 5 wins

CLASS C (from 5 wins in CLASS D)

The duration of the contest will be 3 rounds of 2 minutes the male and female categories.

Optional hull evenings events binding in more than a match on the same day - you can look for the KO the opponent.

Base score: Three chronological criteria

EFFECTIVENESS - TECHNICAL – OFFENSIVE

The most effective will be declared the winner.

To pass from **CLASS C** to **CLASS B** need to get 10 wins

To pass from CLASS C to CLASS B need to get 10 wins

The duration of the contest will be 3 or 4 rounds of 2 minutes in the male and female categories.

No helmet, you can search the KO of the opponent.

Base score: Three criteria chronological order

EFFECTIVENESS - TECHNICAL – OFFENSIVE

The most effective will be declared the winner.

To pass from **Class B** to **Class A** need to get 5 wins

CLASS A (from 5 wins in CLASS B)

AMERICAN FREE BOXING - FREE JAPAN KICK BOXING

The duration of the contest will be 5 rounds of 2 minutes in the men's category and 3 rounds of 2 minutes in the female.

FREE ORIENTAL K-1 – FREE THAI BOXING

The duration of the contest will be 3 or 5 rounds of 3 minutes in the men's category and 3 rounds of 2 or 3 minutes in the women.

Base score: Three criteria in chronological order

EFFECTIVENESS - TECHNICAL – OFFENSIVE

The most effective will be declared the winner.

- **BREAK TIME FOR ALL CATEGORIES IS 1 MINUTE BETWEEN ROUNDS**
- **FOR PF-D CLASS AND C FIST SCHOOL ON ROTATION (SPINNING BACK-FIST) IS PROHIBITED**
- **DIRECT HIT KNEE GRIP (CLINCH DURING THE TIME OF IMPACT) WITH ONLY ONE HIT KNEE DURING THAT GRIP (GRIP OR THE CLINCH SHOULD AUTOMATICALLY BE CANCELED AT THE TIME THE KNEE BLOW HAS BEEN IMPACTED) IN OTHERWISE NOT IT WILL NOT BE PUNTUABLE IF ACTION MAINTAINS GRIP**
- **HIT WITH KNEE TO THE FACE IS AUTHORIZED, IN THIS CASE IS THE KNEE WHAT GOES TO FACE AND NOT HANDS THAT TAKE FACE TO THE KNEE**

SUMMARY RULES FOR CATEGORY:

In chronological order:

1º EFFECTIVENESS 2º TECHNICAL 3º OFFENSIVE (for all categories)

AMERICAN FREE BOXING (FULL-CONTACT) - Valuation

Fist face and body	1 Point
Kick to the body above the waist	2 Point
Kick to the Face	3 Point

* It is scored and valuated only technically effective punches

JAPAN FREE BOXING (KICK BOXING) - Valuation

Fist face and body	1 Point
Kick to the thigh and body	2 Point
Kick to the Face	3 Point

* It is scored and valuated only technically effective punches

ORIENTAL FREE BOXING (RULES K-1) - Valuation

Fist face and body	1 Point
Kick to the thigh and body	2 Point
Knee to the thigh and body	2 Point
Kick to face	3 Point
Knee to the face	3 Point

* It is scored and valuated only technically effective punches

FREE THAI BOXING (MUAY THAI) - Valuation

Fist face and cuerpo	1 Point
Kick to the thigh and body	2 Point
Knee to the thigh and body	2 Point
Elbow to the body and face	2 Point
Kick the face	3 Point
Knee to the face	3 Point

* It is scored and valuated only technically effective punches

IMPORTANT NOTE: The 3rd Criterion **offensive** is valued by the pressure of having the center of the ring, which always goes forward forcing his opponent to turn back, in short conducting combat

PUNCTUATION:

- The referees will write down all the fights the winner will be declared with 10 points
- In such system, the loser of each combat receive a proportionately smaller number of points. But in any case the loser will not have a grade below 7 points, except for multiple accounts of protection or negative points
- After correctly analyzing the three criteria estimated NULL, the judge scored a 10 for both competitors.
- The judges write down your score as the basis of points for each assault:
 - 10-10** When neither competitors was higher in any of the three criteri
 - 10-9** When one of the two competitors was higher in one of the three criteria chronological order
 - 10-8** When one of the two competitors dominated completely and effectively put his opponent in a situation of possible account or protection
 - 10-7** When one of the two competitors dominates performing two counts of assault protection

IMPORTANT NOTE :

PENALTIES FOR DELAY: 3 calls, were conducted one every minute on the third ring and a negative disqualification after five minutes:

NATIONAL CHAMPIONSHIPS

- 1° The club must be affiliated with GBF
- 2° The competitor must be in possession of their annual federal license and health insurance in force.
- 3° Deposit and Participation to compulsory registration

4° Any breach undeclared at least seven days notice (in writing). You will have an additional fine of 20 Euros (except in cases of force majeure).

IMPORTANT NOTE: Failure force majeure (sending the medical certificate on schedule by email.

5° Respect weighing schedules

INTERNATIONAL CHAMPIONSHIPS

Fighting called "**PRO**" must refer to the regulations of the International Federation concerned in mutual agreement with **GBF**.

Fighting called "**PF-D-C-B-A**" must refer to the regulations of the respective International Federation approved by **GBF**.

ADMINISTRATIVE AND SECURITY

1° The request for the approval of the event must be processed two months in advance (see page and fill No. 3 Information)

2° The organizer will have to make available:

- Dressing room for Men and women
- Dressing room for official
- weighing room - medical examination - doping control.

3º The lights must be 3.5 meters above the base ring.

MEDICAL EXAMINATION BEFORE THE EVENT

Given the "features" of this medical examination not suitable for combat is granted, if the following abnormalities occur.

Fever	abnormal pupillary reflexes
Drainage (blood in nose / ears)	Unhealed wounds on face
Romberg positive	greater than 100 mm heart rate
Tension	painful joint mobility

IMPORTANT NOTE: The assessment of this review, is subject to medical judgment, this may request a hematocrit and urinalysis, in case of suspicion of dehydration or doping (medical regulation)

FINANCE

1. The Organizer shall bear the expenses of official 5 (1 Supervisor and 4 Judges / Referees)

By car: € 0.25 per Km plus tolls.
