REGUTATION GBF

These rules are there to try to protect all affiliates, trainers, competitors, referees and promoters. With which any agreement can be reached that the parties involved consider appropriate, as long as GBF is up to date and accepts them so as not to harm third parties.

1º All clubs, associations or federations may benefit from being registered in as many disciplines as the **GBF** welcomes with a single annual club, association or federation affiliation.

2º Active Trainers, Monitors, Assistant Coaches, Coaches and Referees are required to have their corresponding annual **GBF FEDERATIONAL LICENSES** in force.

If you do not have a valid **PROFESSIONAL TRAINING LICENSE**, our database programs will automatically deregister you as a graduate and the title will not have any validity.

3º All athletes to attend official GBF competitions must have in possession the **SPORTS PASSPORT** and the valid annual **FEDERATIVE LICENSE**.



4º Athletes may be **AMATEUR, AMATEUR, PROAM** or **PROFESSIONAL**, and may obtain a **FEDERATIONAL** license approved by **GBF** at an international level.

Each **GBF** Delegation in each country must obtain the appropriate Medical Insurance according to its current legislation. If applicable, if **GBF** is required, depending on the country of origin, it may issue international insurance.

5º Every boxing competition must be composed of at least 5 fights, which may be either male or female.

No fight will be authorized without the Promoter having submitted a request 20 days in advance.

6º The **GBF** Sports Regulations are governed by international standards.

7º **GBF** qualifications at an international level will be awarded in the sports field in the following way:

- 1st Level
- 2nd Level
- 3rd Level
- 4th Level
- 5th Level (Assistant Trainer)
- 6th Level (Coach)
- 7th Level (Monitor)
- 8th Level (Regional Coach)
- 9th Level (National Coach)
- 10th Level (Technical Training)

8º As a **GBF** teaching qualification, the titles of:

- Assistant Coach (5th Level)
- Coach (6th Level)
- Monitor (7th Level)
- Regional Coach (8th Level)
- National Coach (9th Level)
- Technical Training (10th Level)
- Regional Referee
- National Referee
- International Referee
- World Referee.

9º **GBF** will organize exam calls and training courses during the year, having to indicate the place, dates and name of the **TECHNICIANS** who will teach the training courses (**TECHNICIANS**, **MONITOR**, **REGIONAL - NATIONAL COACH** and **REFEREES**).

To examine from 1st Level to 4th Level, the **MONITOR** qualification will be necessary.

To examine from the 5th Level to the 6th Level, the **REGIONAL COACH – NATIONAL COACH** qualification will be necessary.

To examine from 7th Level to 10th Level, the **TRAINING TECHNICIAN** qualification will be necessary.

10º The Refereeing Committee must hold an annual recycling course for experienced referees and a minimum of 2 courses per year for beginners.

The Referees Committee will be in charge of delivering the qualifications, this department has to try to be as independent as possible.

11º At the National and International level, the following federative licenses will be issued:

- . CHILDREN'S federative license (Less than 14 years old)
- JUNIOR Class E license (from 14 to 17 years old)
- AMATEUR License Class D (18 years and older) Not valid for competition
- AMATEUR Class C License (18 years and older)
- PROAM Class B license (18 years and older)
- Class A PROFESSIONAL License (18 years and older)
- Class A1 PROFESSIONAL License (45 years and older)
- PROFESSIONAL TRAINING license (special teaching) not valid to compete.

The Professional federative license will include Sports Medical Insurance as well as Civil Liability Insurance for damages to third parties (Only for Spain).

In the rest of the world, annual federation licenses, medical insurance will be on behalf of others as GBF does not have legal jurisdiction. Requirements to obtain an Annual Federative License:

- Duly completed application scanned
- Photocopy of the ID of the interested party scanned
- 1 scanned passport size photo
- Scanned Medical Certificate (For competitors)
- Photocopy of scanned proof of payment

All documentation must be sent by e-mail secretary@gbfworld.com

12º All athletes affiliated with **GBF** have the right to hold grade exams and compete in all championships for which they are qualified.

Every athlete who participates in official competitions must present the Medical Review Certificate to the GBF secretary.

This Medical Certificate will be valid for one year from the date of issue.

13º All athletes to attend official **GBF** competitions must obtain a **SPORTS PASSPORT**.

This **SPORTS PASSPORT** will be valid in the current year, in which all types of sporting events that said competitor attends (training courses and official championships) will be registered.

These official courses and championships will be approved by **GBF**.

14º In the corner of the Ring, the competitor must be accompanied by a coach duly certified by GBF, and will wear a tracksuit or clothing from their gym. There may also be 2 corner assistants if duly certified by GBF are required.

15º **GBF** must appoint a Supervisory Delegate who will be in charge of the smooth running of the competition and sending the results to the Competition Committee. The Supervising Competition Delegate will have the obligation to fill out sheets with the results and send them to the Central so that the fights are recognized and approved.

In the event that the Supervisory Delegates fail to comply with these rules, they will be dismissed.

16º **GBF** recognizes the right of its affiliates to participate in other championships of other federations or associations, as long as **GBF** Central is notified beforehand.

These results must be reflected in the **GBF SPORTS PASSPORT**.
Affiliates or clubs that fail to comply with this rule will be sanctioned by the **GBF** Disciplinary Committee.

17º All **GBF** athletes who go abroad to compete must notify the Central Office in writing 10 days in advance so that it can process travel permits. In the document they must specify the name of the athletes who have to travel, the place of celebration, the date and time.

If these athletes access on their own without informing **GBF** Central, they will be sanctioned by the Disciplinary Committee.

18º MEDICAL CERTIFICATION: A competitor will not be allowed to participate in a fight if he or she does not have the annual **FEDERATIVE LICENSE** in force with its corresponding Sports Medical Insurance and Sports Passport, and must also possess the Medical Certificate, issued by a qualified Doctor in Sports Medicine. that certifies whether the competitor is fit to fight. This Medical Certificate will be valid for one year from the date of issue.

MEDICAL EXAMINATION: During the period of time dedicated to Weighing, and before being weighed, a competitor must be considered FIT (after having been examined by the Official Medical Officer designated by the Competition Committee).

19º Throughout the world the **OFFICIAL GBF** approvals (Titles at stake) will be as follows:

REGIONAL CHAMPIONSHIP
NATIONAL CHAMPIONSHIP
INTERNATIONAL CHAMPIONSHIP
CONTINENTAL CHAMPIONSHIP
INTERCONTINENTAL CHAMPIONSHIP
WORLD CHAMPIONSHIP

In addition, **GBF** will host another type of **OFFICIAL GBF** approvals (Titles at stake) that will be expanded but at the moment due to demand they remain as follows:

IBERIAN CHAMPIONSHIP
MEDITERRANEAN CHAMPIONSHIP
PANAMERICAN CHAMPIONSHIP

Approval prices are NOT negotiable although **GBF** reserves the right to reach any agreement with the promoters. In **GBF** competitions, the promoters will be responsible for paying the stay and the arbitration fee stipulated by **GBF**.

20º In **BOXING** the **AMATEUR REFEREE** uniform will be, **WHITE** Shirt (Long sleeve) with **GBF** logo with black bow tie, black pants, black socks and black sneakers.

The **PROFESSIONAL REFEREE** uniform will be **LIGHT BLUE** Shirt (Long Sleeve) with **GBF** logo with black bow tie, black pants, black socks and black sneakers



21º **GBF** will authorize the participation of competitors from other federations or associations in its championships, to do so they must obtain the 1-Day federation license. The 1-day license (includes sports medical insurance)

22º **GBF** will periodically organize National, Children's, Cadet and Senior Leagues, qualifying for the National, International and World Championships. In each country, a National team will be prepared to compete every 2 years in the championships that will be organized at the continental and World level. With this measure **GBF** aims to achieve greater technical quality than its competitors.

23º The competition regulations in each **GBF** discipline are the only ones valid to sanction **GBF** fights and titles. In case of disagreement, the Coach and competitors will have to submit to what the College of Referees decides.

24º The Promoters must obtain the license of:

PROAM PROMOTER - Exclusively **AMATEUR** and **PROAM** Events (With or without titles at stake).

PROFESSIONAL PROMOTER - **PROFESSIONAL** Events (With or without Titles at stake).

The Promoters have the obligation to cover the expenses of a supervisor (**EDITOR**) for each evening, who will take care of sending to **GBF** Central once the sporting event or training course has taken place, the chronicle, photos, videos, official results and minutes once carried out the sporting event or training course, for subsequent publication on our website www.gbffworld.com and registration on our official platform <https://fightersrec.com/>

If two promoters agree on the date and place, it will be submitted to **GBF** for study.

25º **GBF** will recognize all regional, national and international federations or associations by appointing a **DELEGATE** in each country, the competitions will be governed by the **GBF** Regulations in their different disciplines.

26º **GBF** grants itself the power to dismiss any delegate who acts in bad faith or against the interests of **GBF** whether at the regional, national or international level.

27º **GBF** in its desire for growth will help all affiliated clubs and athletes to the extent possible.

28º The competition doctor will have to be recognized by **GBF** and demonstrate that he has the knowledge that the combat disciplines need.

29º Create a network of doctors, specialists in Contact Sports, throughout the National territory in each country.

30º If another federation acts in bad faith by preventing the growth of **GBF** or harms any of its athletes, it will be automatically sanctioned by **GBF**, preventing the participation of its athletes in championships of that federation, association or organization.

31º International Delegations must pay the deductibles annually. Payments must be made from January 1 to 10.
